INTRODUCTION

The Vancouver Paranormal Society welcomes you as a member. We hope you enjoy, learn and find value in the activities and investigations we undertake. If a member has any questions please don't be afraid to voice it. We take every precaution to ensure that no harm comes to a person. If asked to leave an investigation by either a member of the authority, officer or senior member of the Society, please do so quietly and in an orderly fashion.

SOCIETY RULES

Investigating paranormal activites is not normally a dangerous activity provided one is aware, attentive, grounded and healthy both mentally and physically.

Do not operate or touch equipment you have not received any training with. Any equipment used by members and belonging to the Vancouver Paranormal Society remains the property of the Vancouver Paranormal Society and must be returned in same condition.

Be cautious and careful and avoid any activity that might put you at risk such as horseplay or inattentive behavior.

We do not tolerate the use of illegal drugs at anytime or allow anyone to be intoxicated on investigations.

Carry photo I.D. and provide a contact name in case of emergency. Please advise of any health problems or allergies.

Your participation is voluntary and is undertaken at your risk. In becoming a member of Vancouver Paranormal Society, you agree to hold Vancouver Paranormal Society, its

Directors, staff and members harmless or not to blame from any mishap, injury, loss or damage occurring as a result of participation in, or traveling to and from events and investigations, including out-of-province trips.

No member should conduct an investigation on behalf of the Vancouver Paranormal Society that is not sanctioned or approved by the Society. Any members, who decide to conduct their own investigation without the authorization of the Society, may be deemed as trespassing on private property and charged if caught by the authorities.

If a question is raised to do with the investigation point the client towards a senior member of the team. You should not give your opinion to the client without consulting with the team leader. You are an investigator – to document findings and gather evidence.

You must give the President or Vice President notice of at least 24 hours if you decide not to attend an investigation. In case of an emergency notification as soon as possible by telephone call is appreciated.

We do not trespass. We always receive permission to be at any location and we request that you wait outside a location until a senior member of the team gives you access.

The Investigation Report must be given to the team leader by email within four days of the investigation.

Any information/findings on an investigation must be handed to a senior member of the society within one week after the investigation and is the property of VPS.

Information gathered from an investigation is confidential and not to be divulged to anyone not a member of the Vancouver Paranormal Society without the consent of the team leader and consent of the client. This information includes audio files, photographs, reports and video. All information, print material, third party publications, logos are property of Vancouver Paranormal Society and cannot be used or reproduced without the consent from Vancouver Paranormal Society.

No member must have a criminal record and a police record can be requested at any time. Dishonesty or enrollment with another group, which may cause a conflict of interest, may result in your membership being revoked.

All members are expected to arrive on time to investigations with proper equipment and clothing unless otherwise advised by a senior member. Members must meet with the standards of proper grooming.

All investigations are for active members of the Vancouver Paranormal Society only. Do not bring spouses, significant others, friends or relatives.

All members are expected to help out on bringing investigations to our group.

All investigations are private and evidence or investigation details will not be shown or discussed with people outside VPS.

All Society-related emails shall be CCed to President Peter Renn.

Members are expected to respond to VPS emails in a timely fashion and within 48 hours unless it is an emergency or last minute change of plans. In that case the response should be as soon as possible.

In signing below, I agree to follow the directions and instructions of the team leaders, and to follow the prescribed protocols. Due to the intent of investigations being there to provide the client with factual evidence if the investigator decides not to submit a report within time given the investigator will be no longer asked to further investigations unless they can provide a suitable reason why they cannot do so.
